Nekhanevych, acting on the basis of the Statute (hereinafter referred to as the Publisher), on the other hand concluded this agreement is as follows:

**1. Scope of the contract**

The author grants the Publisher free of charge the exclusive right to use a written work (scientific, technical or other)

(hereinafter referred to as the Work), stated in any language, under the conditions specified in this Agreement.

**2. Copyrights that are passed to the Publisher**

2.1. The author grants the Publisher the right to use the Work in the following ways:

2.1.1. To use the Work by publishing it in the journal "Medicni perspektivi" (hereinafter - the Edition) in any language (agreed by the Publisher and the Author), a copy of the Work, accepted for publication, is an integral part of the Copyright Contract).

2.1.2. In the course of editorial preparation, the Work is modified, adapted or otherwise modified in agreement with the author.

2.2. If the Publisher reveals a desire to use the Work in other ways: to translate, to place entirely or partially on the Internet; publish the Work in other, including foreign, editions, include the Work as an integral part in other collections, anthologies, encyclopedias, etc., the terms of such use are made by the annex to this Agreement.

**3. Territory of using**

The author grants to the Publisher the right to use the Work in the ways specified in clauses 2.1.1-2.1.2 of this Agreement on the territory of Ukraine, as well as the right to disseminate the Work as an integral part of the Publication on the territory of Ukraine and other countries by subscription, sale and free transfer of the publication.

**4. Reservation**

4.1. The author states that:

- he is the author (co-author) of the Work;
- the copyrights to this work are not transferred to another publisher;
- this Product has not been previously published and will not be published in any other publication prior to the publisher's publication;
- he has the right to authorize the use of the Work under this Agreement, if the Product was created in connection with the performance of the employment contract;
- he did not violate the intellectual property rights of other persons. If the Work contains the materials of other persons, except for citing cases in the extent justified by the scientific, informational or critical nature of the work, the use of such materials by the Author is in compliance with the rules of law.

**5. Rights granted to the Author**

5.1. The Publisher grants the Author the right to use the Work in the following ways:

5.1.1. Receive a copy of the Work in a quantity that under the rules for authors of the journal.

5.1.2. Freely distribute copies of the Work received from the Publisher both on the territory of Ukraine and abroad.
